INSPECTION OF THE ELECTRODE

Sebbene i più moderni dispositivi siano dotati di sistema per l'inversione della polarità negli elettrodi di generazione, al fine di minimizzare il deposito di calcio (calcare) sulle lame degli stessi, viene tuttavia raccomandata un'ispezione regolare.

REMOVAL OF THE ELECTRODE

Make sure that the electrolytic generator is turned off and disconnected from the power supply. STEP 1 - Disconnect the electrode.

STEP 2 - Unscrew the threaded ring nut.

STEP 3 - Remove the electrode from the cell. Check if there is calcium (a substance similar to gypsum) inside the electrode.

In the presence of calcium, the electrode needs to be cleaned.

If it does not need to be cleaned, assemble the electrode again.



CLEANING THE ELECTRODE

Prepare a solution consisting of 1/8 of hydrochloric acid and 7/8 of water. Immerse the electrode in the solution. Calcium will dissolve by chemical reaction. When the reaction stops (about 10 minutes) rinse the electrode with clean water, dry the brass terminals and check that all the calcium has been removed. If not, repeat the process with a new solution.

WARNING:

When handling substances such as acids, the use of suitable personal protective equipment, such as protective goggles and rubber gloves, is strongly recommended.

During preparation, add acid to water, NEVER water to acid.



CLOSURE OF THE BODY SYSTEM (CELLS) AND ELECTRODE

Make sure that the sealing gasket is correctly positioned in its seat. Reinsert the electrode in the cell and tighten the locking system. Connect both electrode poles to the generator and turn it on.
